RE: Support for SB 236

Chair Smith Warner, Vice Chair Drazan, Vice Chair Holvey, and members of the House Rules Committee,

Our Children Oregon's (OCO) mission is to be a voice and force for the common good for all Oregon children, ensuring all children have the resources and opportunities they need to reach their full potential. OCO is the result of the merger between two historic Oregon non-profits: The Children's Trust Fund of Oregon and Children First for Oregon. We elevate data and lived experience to prioritize children and center communities. We continue to connect a community of 115 advocates, coalitions, and organizations through The Children's Agenda, a legislative agenda championing equitable state legislative policies and shared investments to improve the lives of Oregon's children and their families.

SB 236 to reduce and eventually eliminate suspension and expulsion in early care and education programs is a priority item on the 2021 Children's Agenda.

National data shows that Black children, Native children, and children who experience disabilities are asked to leave early care and education programs at disproportionately higher rates than other children. Black children experience expulsion rates from preschool at a rate 3.6 more than white children. Last year's [statewide household survey](#) completed as part of the Oregon Preschool Development Grant found that children who were American Indian/Alaskan Native/Hawaiian Native and those who were multi-racial/multi-ethnic were about three times more likely than white children to be asked to leave care.

Young children and families that experience suspension and expulsion may carry a stigma beginning in these early years which continues through their education. Early care and education providers play a critical role in preventing this stigma. Without adequate professional support, providers may see suspension and expulsion as a last resort. Oregon must do better. We can support providers to include every child. Young children who are included in their classrooms can thrive and are more

is a broad slate of equitable investments and policy solutions to meet the holistic needs of Oregon children, youth, and their families.

likely to be included in kindergarten classrooms and beyond.

SB 236 works with HB 2166 to marshal robust coaching and support for early care educators to have the tools to better support children in their programs, and ultimately moves us toward more inclusive child care and preschool settings across Oregon. In order to make progress on suspension and expulsion in early childhood, Oregon must:

- clearly define suspension and expulsion
- collect data for accountability and improvement
- support early childhood educators to build the skills that allow all children to thrive, such as anti-bias training and infant-toddler-early childhood mental health consultation
- ultimately commit to an end to suspension and expulsion by July 1, 2026
