RE: Support for SB 236

Chair Power, Vice-Chair Zika, Vice-Chair Reynolds, and Members of the Committee,

Our Children Oregon's (OCO) mission is to be a voice and force for the common good for all Oregon children, ensuring all children have the resources and opportunities they need to reach their full potential. OCO is the result of the merger between two historic Oregon non-profits: The Children's Trust Fund of Oregon and Children First for Oregon. We elevate data and lived experience to prioritize children and center communities. We continue to connect a community of 115 advocates, coalitions, and organizations through The Children's Agenda, a legislative agenda championing equitable state legislative policies and shared investments to improve the lives of Oregon's children and their families.

**SB 236 to reduce and eventually eliminate suspension and expulsion in early care and education programs is a priority item on the 2021 Children's Agenda.**

National data shows that Black children, Native children, and children who experience disabilities are asked to leave early care and education programs at disproportionately higher rates than other children. Black children experience expulsion rates from preschool at a rate 3.6 more than white children. Last year's [statewide household survey](#) completed as part of the Oregon Preschool Development Grant found that children who were American Indian/Alaskan Native/Hawaiian Native and those who were multi-racial/multi-ethnic were about three times more likely than white children to be asked to leave care.

["Supporting the First 1,000 Days of a Child's Life: An Anti-racist Blueprint for Early Childhood Well-being and Child Welfare Prevention"](#), a recent report from the Center for the Study of Social Policy, highlights the importance of promoting well-equipped early learning settings for young children of color and equitable policies that eliminate the disproportionate expulsions of children of color in child care and preschool settings. These negative early experiences impact future educational outcomes, and

show that the school to prison pipeline begins in our early care and preschool settings.

We must equip our early childhood providers with the tools they need to disrupt the cycle of over-disciplining kids of color and labeling their behavior as problematic.

SB 236 works with HB 2166 to marshal robust coaching and support for early care educators to have the tools to better support children in their programs, and ultimately moves us toward more inclusive child care and preschool settings across Oregon. In order to make progress on suspension and expulsion in early childhood, Oregon must:

- clearly define suspension and expulsion
- collect data for accountability and improvement
- support early childhood educators to build the skills that allow all children to thrive, such as anti-bias training and infant-toddler-early childhood mental health consultation
- ultimately commit to an end to suspension and expulsion by July 1, 2026

Thank you for your consideration, and we **strongly urge you to support SB 236 with an additional amendment that would at a minimum cover all publicly funded programs.**
